



Rules of Use

Purpose

The Big Air Bag (the infrastructure) is managed by the Leysin Big Air Bag Foundation (the Foundation). The infrastructure is intended for skiers or snowboarders (the user); members of a federation, an association or a team (the client), supervised by a trainer(s); and exceptionally for unaccompanied users with express written authorization.

Opening Hours

The infrastructure is open pursuant to variable schedules based on demand and weather conditions, which are determined by the Foundation.

Access to and use of the facility by clients and users is subject to the facility being officially open and to the presence of its management.

Number of users of the Big Air Bag

A maximum of 16 users will be allowed in each session. Sessions will be organised by combining different groups where appropriate.

Respect for the premises and the equipment

Clients and users must comply with these rules and with all technical and safety instructions issued by the infrastructure management.

Users must confirm that they are covered by civil liability insurance covering any damage caused to the facility or to third parties and that they have individual accident insurance.

Any defect, damage or malfunction of the infrastructure must be reported immediately to the infrastructure management.

Any user who causes damage to the infrastructure or to third parties on the site, even through negligence, is obliged to repair it. Any costs caused by the damage in question shall be borne by the user responsible, or failing that, by the client.

Operation and Use

The client and users must comply with the following guidelines :

- The client and users must arrive at the facility 30 minutes before the time the facility is booked and confirmed;

- The infrastructure management will give verbal instructions on the use of the infrastructure and the safety rules;
- The skis and snowboards must be in good condition. The edges must not be damaged;
- The infrastructure management must check the equipment of the users, in particular the skis, snowboards, bindings and stoppers;
- If necessary, the edges of skis and snowboards must be rounded with a rubber to make them less sharp;
- Every user must wear a helmet.

Responsibility and release

Before each use of the infrastructure, all users shall read the "Release & Consent" document (the release), date it and sign it. If the user is a minor, his or her legal representative shall indicate his or her first and last names and also sign the document.

The release is valid for the period of use specified in the reservation. Each user is required to sign a new discharge in the event of a new reservation.

It should be noted that by signing the waiver, each user releases the Foundation and any related entity and/or their directors, officers, employees, auxiliaries from any liability for any loss, injury or damage resulting from or in connection with his or her use of the Big Air Bag facilities and equipment. In accordance with Art. 101 of the Swiss Code of Obligations, gross negligence is reserved.

Accident and security

Each client and user must :

- Be aware that they are using the Big Air Bag facilities and equipment at their own risk ;
- Confirm that they are healthy, fit and have undergone training ;
- Acknowledge that there are risks and hazards associated with the use of the Big Air Bag facilities and equipment ;
- Have accident insurance ;
- Be covered by liability insurance for any damage caused to the Big Air Bag infrastructure and equipment, third parties or other users.

In the event of an accident, the user agrees to be treated in accordance with the standards established by the Leysin Big Air Bag Foundation in the event of an accident.

Parking

Cars are not authorized next to the infrastructure or in the area reserved for the camping cars.

Cars and busses have to be parked next to "La Maison du Sport Vaudois".
